#### Socialisation of Breeding cats and kittens

As most of the kittens bred by breeders will end up in pet homes, the socialisation of the kittens as they grow is a vital part of any health management plan. This ensures that when they enter their new homes, they will do so as a happy and well-adjusted kitten, able to cope with the stresses of an unfamiliar environment.

Enrichment of the environment is also just as important for the adult cats – as many desexed adult cats may likewise spend their retirement in a new home after their breeding life is finished, it is important that they too are socialised and happy to be handled by strangers and will cope with the stress of moving into a strange new home.

Socialisation of cats and kittens is covered under the Code with regards to the expectations to be provided by breeders for their cats, to ensure their welfare is met, and it is a very important aspect of the daily routine of the cat.

Cats of all age and breeding status must be provided with a minimum amount of daily socialisation, handling and environmental enrichment which ensures they are adequately mentally stimulated.

An enrichment, socialisation and handling management plan needs to form part of a breeders' health management plan, and should be planned specific to the breed/type of cat (including any retired animals) – a highly active breed may require additional needs to one who is far less active. This can be formed in conjunction with a veterinary practitioner and other breeders of your breed if you are unfamiliar with the needs of your breed.
